Overview - In 2023, Audubon Water Company continued system-wide improvement projects.

Water Source - Audubon Water Company is supplied by ground water pumped from twelve (12) wells, most of which are near the Audubon section of Lower Providence Township.

Required Additional Health Information - To ensure that tap water is safe to drink, EPA prescribes limits on the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. Sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs and wells. As water travels over the surface of land or through the ground, it dissolves naturally occurring minerals and radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in water include:

- (A) Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.
- (B) Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban storm runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.

- (C) Pesticides and herbicides, which may come from a variety of sources such as agriculture, storm water runoff, and residential uses.
- (D) Organic chemical contaminants, including synthetic and volatile organics, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban storm water runoff and septic systems.
- (E) Radioactive contaminants, which can be naturally occurring or be the result of oil and gas production and mining activities. In order to ensure that tap water is safe to drink, EPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water, which must provide the same protection for public health.

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infection. These people should seek advice about drinking water from their health care providers. Monitoring Requirement Not Met for Audubon Water Company

During the time periods below, Audubon did not monitor for these contaminants and therefore can not be sure of the quality of your drinking water. Audubon did not test for SOC's at its wells that were not in operation, all other tests were in compliance. A radiological test was missed, but was taken, late for first quarter of 2023. Audubon did not monitor for IOC's at its wells. Audubon failed to collect a VOC and a Nitrate/Nitrite in 2022 at one of its wells. Also did not collect Radiologicals for the same period. This well DID NOT operate during this period of time.

Lead and Copper Statement

If present, elevated levels of lead and copper can cause serious health problems, especially for pregnant women and young children. Lead and copper in drinking water is primarily from materials and components associated with your service lines and home plumbing. Audubon Water is responsible for providing high quality drinking water, but can minimize exposure by flushing your tap for a minimum of 30 seconds before using water for drinking and cooking.

How to Read The Water Quality Table

This report is based upon tests conducted in the year 2022 by Audubon Water Company. Terms used in the Water Quality Table and in other parts of this report are defined here.

Maximum Contaminant Level or MCL: The highest level of contaminant that is allowed in drinking water MCL's are set as close to the MCLGs as feasible using the best available treatment technology.

Maximum Contaminant Level Goal or MCLG: The level of contaminant in the drinking water below which there is no known or expected risk to health, MCLGs allow for a margin of safety.
